Please contact your regional director if you have any questions. Remember, the minimum required membership was lowered this year to 10 renewing members.

Please make sure you are updating your officer's information form on the website. It is important for the directors to have up-to-date contact information for each branch. It is also important from an insurance stand point. If the officer's information is not up to date, the officers are not covered by the D&O insurance provided to the officers for each branch. We appreciate the feedback we receive from the members concerning the website. This is how we make improvements. We know everything

isn't perfect and it doesn't always run like a well-oiled machine, but we are working each day to improve it. Please help us make things better for everyone; if you have suggestions on improvements let us know. Please be patient as we work to make the improvements.

The Safety Zone: (Submitted by Richard Borgaro, COCC Safety Officer):

There are certain truths that we can depend on. Here's one: Accidents happen. Unless you live in a vacuum - and even then, a vacuum seems vulnerable to external forces - accidents will happen.

The good news is that we can do much to prevent accidents, and that's a vitally important thought to consider as we end the show season for 2017.

Safety is one of our most basic responsibilities. We owe it to our families, our friends, and to all the people that come to our shows. When everything is said and done, we owe it to ourselves. And why wouldn't we put a priority on safety?

Because it cost too much? Bet it doesn't cost as much as hospital bills, funerals or lawsuits.

Because it takes too long? Bet it doesn't last as long as a regret.

Because it might decrease the number of exhibitors or attendees? An accident at a show is not likely to grow attendance.

One of the leading topics of conversation in this hobby today is how to boost show attendance.

A comprehensive safety plan is an excellent place to start. If you give people a choice of attending a safe event or a dangerous one, the vast majority will choose safety.

Safety doesn't have to be expensive. It doesn't have to look like a police state. It can be done in a friendly, respectful and effective manner. All I am asking is keep safety in the back of your mind.

We all know when we are doing something that doesn't feel right and could lead to disaster. We all know when we see someone that is just stepping across the line, and hoping they will not have an accident. We need to stop, and take a

"Time Out" and count to 10. Take a couple of seconds to look at what we are about to do, the safe procedure will be apparent. Let's all be safe and set an example, rather than turning a blind eye.

I have included in this safety article two photos of major accidents which involved antique tractors. I could write many, many paragraphs describing every detail of the incident. But I think that a photo is worth a thousand words. Even if you did every safety procedure correctly, and ran in to a brick wall, there are going to be one or more items on our trailer that are going to fail.

Please - take the time this winter to check every single component that makes up the "Hold down system" on your trailer. We all by now know the importance of checking annually the condition of chains, chain binders, web strap style binders. But don't forget about the condition of that D ring or whatever location you choose to hook that chain to on your trailer. Also think about the spot where you hook that strap or chain to your Cletrac. It must not be a part that could not be torn loose in a head-on collision.

Remember that a chain or is only as strong as its weakest link. Really take the time to analyze what might fail if you need to come to a sudden stop.



As an added note, when I tie down a tractor, I always use my strongest chains to keep the tractor from going forward on the trailer. There should be one on each side of the tractor to the trailer side.

Branch dues for next year will not change from last year. Dues will still be \$12 per year per member which includes the EDGETA National Dues as well as the insurance premium. We would like to have as many dues as we can by March 15th. The EDGETA National policy premium is due shortly thereafter. Our EDGETA insurance year is from the middle of April to the next April.

There has been a recall on Kidde Brand fire extinguishers. Search for 'Kidde fire extinguisher recall 2017' on the internet to be sure yours not being recalled.

Thanks once again for taking the time to be safe. Our goal as you know is at the end of the day everyone goes home safe and happy.

Off I would go bare foot, hopping on one foot while picking sand burs out of the other, then alternating. I can tell the memories to my kids and grandkids, but they will never mean to them what they mean to me. Yet, they will remember when I gave up my flip phone for an iPhone 5.

The first new tractor my dad bought was an 8N Ford with all new Dearborn implements in 1948. By the time I was 10 my dad had taught me to drive it. I was blessed to get to farm with him until he started battling cancer in 1955. He passed away in 1958, and the tractor was sold out of the family, but I'm thankful I now have it back, along with the implements.

My children have little real knowledge of farming except for what they have read in books. Although we love each other dearly, I have not been able to give them the same fondness for antique tractors and engines that I have. Hall of Fame Award

Early Day Gas Engine & Tractor Association (EDGETA) honors members who have made a significant contribution to EDGETA by presenting a HALL OF FAME plaque at a National or Regional Show and putting the inductee's picture and name on line. The Hall of Fame (HOF) was established in 1998, and every member is eligible for this award. Anyone can nominate any member (posthumous members applications accepted) for this award – just follow the HOF form found on-line at edgeta.com.

The deadline for the 2018 HOF nomination is February 24, 2018. E-mail the application to D Yearian, Chairman – trydiron@hughes.net.

The name of the recipient of the HOF (Branch number and date) will be put on the large EDGETA plaque and their name and picture will be put on line. The nominee will receive a small plaque which can be presented at a National or Regional Show of their choice. A stand-in can accept the award if the inductee is unavailable and prior arrangements are made.

Three (anonymous) judges are chosen – nominees must receive at least 2 votes from the three

judges to win. The on-line form must be followed so that all applications can be judged fairly. Remember this is an EDGETA Hall of Fame and contributions to EDGETA, not just the hobby, should be stated.

The EDGETA National Annual Meeting is June 29-30 this year in Emporia, KS. We have an important item of business that must be considered before you receive the Newsletter the first part of March.

The following two Director's positions are open this year: **North Central, currently held by Robert Craig, and South Central, currently held by Clyde Brummett, Sr.**

If there are any nominations, I must receive the resumes with photos 90 days prior to the National Meeting to be held on June 30, 2018. Please address to Carrie Jo Parmley, 15246 Seven League Rd., Tyler, TX 75703. The date due to me is Friday, March 28, 2018. A banner across the top of the front page of our website is also a reminder that the NC and SC director positions are up for election.

By-Laws pertaining to the election are printed below and are also on our website.

**ARTICLE IV – DIRECTORS/OFFICERS/ADVISORS
Section 1. Directors:**

- a. The Board of Directors shall consist of seven (7) directors which includes the President, Vice President, and Safety Officer.
- b. There shall be one Director from each of the six (6) EDGE&TA Regions with the seventh being a Director at Large.

c. Directors shall be elected at the Annual Meeting by a majority of the branches voting, either in person or by proxy. Every branch may vote to fill all Director positions, both Regional and Director at Large.

d. Any member in good standing may have their name placed in nomination for the Director position in the Region in which they reside.

e. Any member in good standing, from any region, may have their name placed in nomination for the Director at Large position.

f. Nominees must send to the Secretary/Treasurer a resume providing a straightforward profile of themselves and a recent photo. As a minimum, the resume should contain the following:

- (1) EDGE&TA membership history
- (2) EDGE&TA offices held
- (3) Ideas and goals for EDGE&TA
- (4) Knowledge of current EDGE&TA issues

g. The Secretary/Treasurer must receive the resumes and photos no later than (90) days prior to the Annual Meeting.

h. If there are no valid regional nominations presented, the Board of Directors shall appoint a member in good standing from the region to serve until the next Annual Meeting at which time the position shall become vacant.

i. If there are no valid nominations presented to fill the Director at Large position, the Board of Directors shall appoint a member in good standing to serve until the next Annual Meeting at which time the position shall become vacant.

j. For continuity, Directors shall be elected on a rotating basis under the following cycle: Two (2) Directors shall be elected/re-elected in each of the first year, and the second year. In the third year, three (3) Directors shall be elected/re-elected

k. The Board of Directors shall fill a vacated Director position by appointment of an EDGE&TA member in good standing. Directors so appointed shall serve until the next Annual Meeting at which time the position shall become vacant.

l. Directors shall serve a term of three (3) years, and/or until their successors are elected, with the exception that a Director elected to fill a vacated appointed position shall serve the remainder of that three (3) year term.

m. The number of terms a Director may serve is unlimited.
